\$2.00 per child (Child picked up from bus at ST. Paul's Center.)
Parent are encouraged to use our autopay system. Ms Kim e-mails your bill on Monday and the amount is taken
from your account on Friday.
Parents receive their bill on Monday and payment must be received by 6PM on Friday of the same week. A \$10.00
late fee is charged if payment is not received. If full payment is not made by the following Thursday, your children will not be
able to attend our Center until payment is made in full. Initial
\$3.00 per phone call if we have to make a non-emergency call. (Examples: Your child doesn't come within one hour
of scheduled time. Your child does not arrive off of the school bus. Your child comes on the bus without being scheduled.)
If your child attends the Center for less than an hour a day, you will be charged for one hour.
We are not licensed after 6PM. A late Pick-Up Fee is charged at the rate of \$1.00 per minute after 6PM.

CANCELLATION POLICY Initial

In order to avoid being charged, parents of preschool children must call by 6PM on the previous day to cancel and parents of
school age children must call by 9AM on the same day to cancel. If we do not receive a call you will be charged the amount
listed below:
\$ 6.00 School Age
\$12.00 Scheduled Time-4 hours or less
\$24.00 Scheduled Time-more than 4 hours
Parents will be exempt from this charge for 3 times per enrolled child if an emergency occurs and a late cancellation must be
made.

JUNE-AUGUST CANCELLATION POLICY
In order to avoid being charged, parents of children must call by 6PM on the previous day to cancel. If we do not receive a
call you will be charged the amount listed below:
\$12.00 Scheduled Time-4 hours or less
\$24.00 Scheduled Time-more than 4 hours
Parents will be exempt from this charge for 2 times per enrolled child if an emergency occurs and a late cancellation must be
made.
Subsidy Clients must have written authorization that an account has been established in order to begin Child Care. Children
may begin earlier but parents are responsible for full payments. Refunds will be given if paid for later with subsidies.
Students will no longer be enrolled if a bill is not paid according to this policy. Students may return when the past due bill is
paid in full.

writing and signed by the parent and director after receiving advisement from the St. Paul's Board of Education.
